### To Qualify for the Corporate Special:

- At least **3** members must be employed by the same company to qualify for the Corporate rate. *(Employees may be full-time, part-time, husband, wife, it doesn't matter.)*
- Dues must be paid in full by **July 1<sup>st</sup>**.
- Corporate members may pay their dues individually.
- New members may join as Corporate members (\$1100) if at least one full-paying current member is employed with the same company—the total number of employees from the same company must be at least 3. *(For example, if a current member recruits two of his employees, the two employees each pay the \$1100 Corporate rate, but the current member must continue to pay his full membership rate.)*
- Any 2009 and/or 2010 PCC member cannot qualify for the Corporate special (unless they were on the corporate special last year).
- The requirements for this membership will be reviewed on a year-to-year basis. This membership is subject to an assessment fee.
